## **OFF-LICENCE**

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

- (c) Pursuant to section 110(2)(c) of the Act, drinking water shall be freely available to all customers at each point of consumption while alcohol is being supplied free as a sample at all times that the licence is being exercised.
- (d) The Principal Entrance is to be described as: "the entrance into the store off the carpark in Revell Street, Hokitika".
- (e) The following steps must be taken to promote the responsible consumption of alcohol:
  - (i) There shall be a "Host Responsibility Policy", similar to that which accompanied the application dated 19 May 2021, in place at all times.
  - (ii) The extent of the licensed area is shown on a plan accompanying the application for renewal dated 19 May 2021.
- (f) Each of the following parts of the premises are designated as:
  - (i) Restricted Area: Public part of the liquor store.

#### **Duration**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) either-
  - (i) until the close of the period for which it was last renewed; or
  - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issed; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either-
  - (i) until the close of the period of 3 years after the period for which it was last renewed; or

(ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
