

OFF-LICENCE*Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012*

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Everest Limited is authorised to sell alcohol on or from the premises situated at 366 Great South Road HUNTLY and known as Super Liquor Huntly, to any person for consumption off the premises, to deliver it somewhere else, and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1.00 pm on Anzac Day.
- (b) Alcohol may be sold under the licence only on the following days and during the following hours:
Monday to Sunday 9.00am to 10.00pm
- (c) No single sales of beer, cider or RTD's priced at or less than \$6 per unit are to be sold
- (d) The whole of the premises is designated as a supervised area.
- (e) Drinking water is to be freely available to customers immediately adjacent to any alcohol that is being supplied free as a sample on the premises.
- (f) The licensee must take the following steps to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:
 - (i) Display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- (g) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
 - (i) All staff will be trained in their responsibilities under the Act.
 - (ii) A sign shall be prominently displayed inside the premises, which identifies by name the manager on duty responsible for the management of the sale and supply of alcohol under the licence.
- (h) The sale or delivery of alcohol is authorised on the premises generally. The premises situated at 366 Great South Road, Huntly, are more precisely identified in a plan date stamped as received by the Waikato District Licensing Committee on 16 January 2020.

Display of Licence

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from Great South Road is designated as the principal entrance.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) until its expiry date detailed below; OR
- (b) if an application for the renewal of the licence is duly made before the licence expires, until the close of the period 3 years after the expiry date.
