

OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Kapiti Landings Limited Licence Number 45/OFF/002/2023

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Kapiti Landings Limited (the licensee) is authorised to sell and supply alcohol on the premises situated at Unit 1D3, 7A-7C Friendship Place, Kapiti Road, Paraparaumu, known as Super Liquor Kapiti, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

This licence is subject to the following conditions:

- (a) Alcohol is only permitted to be sold, supplied or delivered on or from the premises authorised by the licence.
- (b) Alcohol may be sold or delivered only on the following days and during the following hours:
Monday to Sunday – 9am to 9pm
- (c) No alcohol may be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (d) The whole of the premises is designated as a **supervised area**.
- (e) Water must be freely available for drinking at all times alcohol is being supplied free as a sample on the premises.
- (f) The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and to intoxicated persons.
- (g) The licensee must implement and maintain the steps proposed in the application for the licence aimed at promoting the safe and responsible consumption of alcohol, and minimising alcohol related harm.

Display of Licence and Principal Entrance

A copy of this licence must be displayed at the principal entrance to the premises from Friendship Place.

Licensed Premises



The licensed premises situated at Unit 1D3, 7A-7C Friendship Place, Kapiti Road, Paraparaumu, are more precisely identified as outlined in the plan date stamped as approved by the District Licensing Committee on 9 January 2019 (held on DLC file OFF860).

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) either—
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.
