OFF-LICENCE

Sections 17 to 20 and 64 Sale and Supply of Alcohol Act 2012

DLC Ref: OF123

Pursuant to the Sale and Supply of Alcohol Act 2012 ("the Act"), Nelson Holdings Ltd (the licensee) is authorised to sell and supply alcohol on the premises situated at 132B Tahunanui Drive and known as "Super Liquor Tahunanui South" to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. HOURS

a. Alcohol may be sold only on the following days and during the following hours:

Monday to Sunday 10.00 to 22.00


- No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.
- WATER While alcohol is being supplied free as a sample, free drinking water must be provided for customers at the tasting location.
- 3. **DESIGNATED AREAS** -The following parts of the premises are designated as:
 - a. Supervised area: The Showroom Area.
- 4. **SIGNAGE** Signage must be displayed at each point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.
- There shall be no external signage outside the premises except there may be one A1 size advertising wall
 poster displayed which is visible from the outside of the premises and one sandwich board displaying only
 the word "OPEN".
- 6. **RESTRICTIONS** The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed.

7. OTHER RESTRICTIONS-

- a) No single cans or bottle sales of RTD's.
- b) With the exception of craft beers, no single sales of any beer less than or equal to 500mls other than those that Super Liquor is contractually obliged to range. These will be a maximum ABV of 7.2%.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force until the expiry date or if an application for renewal is received before it expires – until 3 years after the expiry date.
